Form Instructions

- This web based form is a fillable PDF form. Please type in your information, print and mail with Work Order Form and fees or print form and fill in clearly. Forms that cannot be read will be returned. OR USE THE NEW ELECTRONIC REGISTRATION AND PAYMENT FORMS.
- The **BREEDER** is the recorded owner of the dam at the time of mating.
- The **OWNER** is the recorded owner of the dam at the time of birth.
- **MEMBERSHIP NAME** is the precise wording that will be entered onto the registration form by the Registry after "OWNER" and is identical to that used on the Work Order Form for Membership Name.
- **EAR TAG IDENTIFICATION** refers to a unique identification number (ID). This assigned ID cannot be changed in the registry.
- The **FLOCK NAME** (abbreviation) is a unique name for your flock. If the flock name is Tunis Acres (TA) and the ear tag identification is "333", then the animal name on the registration will be Tunis Acres TA 333.
- **SIRE or DAM CHRISTENED NAME** can be any available name in the registry that is not already in use; names are available to NTSRI members. There is a one-time \$25 fee to record a name.
- Entries on the form must be from dams or sires owned by the breeder and owner. If this is not the case, complete and submit the **VERIFICATION OF MATING** form with the order.
- Make check payable to NTSRI.
- Send payment with Work Order Form and Registration Forms to: **NTSRI, PO Box 231, 305 Lincoln St., Wamego, KS 66547**
- Request priority processing by writing "**RUSH**" on the envelope and form. **Do not combine rush work and routine work on the same form. Ensure that rush fees are paid in advance.**
- It is a federal offense to submit fraudulent forms via the US mail.

Verification of Mating

When the sire or dam was owned by someone other than the OWNER at the time of mating, parentage must be confirmed by a Breeding Certificate or Ram Lease form. The person selling a bred ewe or leasing a ram should complete the appropriate sections below and pass to the new ewe owner or ram lessee. This completed form should be submitted to the registry when registering lambs from this mating. A Breeding Certificate records exposure up to 157 days from the last day of mating. Lambs born during this period would be eligible for registration. Breeding Certificates and Ram Leases must bear the original signature of the person issuing the documents.
